# The New MBU Resident Scorecard

After our municipal elections this fall, Miami Beach United will compile a scorecard to educate and inform residents. The new "Resident Scorecard" measures Commission and Commission Committee votes to show how resident friendly the City of Miami Beach Mayor and Commissioners are.
