MOPED SHARING SERVICES PILOT PROGRAM

#### **Executive Summary:**

This resolution seeks to explore a pilot program of electric mopeds as a means of transportation for residents and tourists. And while electric mobility devices, such as ebicycles, e-scooters, and e-mopeds, are becoming increasingly popular and eco-friendly means of transportation across the U.S. and Europe, particularly in urbanized cities, their use poses some very specific challenges to our City that must be resolved before this initiative moves forward.

#### Why It Matters:

- Moped use is a part of the MXE problem because of the way people use them, disregarding city laws and pedestrian and bike traffic.
- The addition of electric mopeds without the necessary corresponding safety precautions can lead to more issues and risk of injury to users, pedestrians and car traffic.
- In general we support new technology solutions that attract a young dynamic population and would be open to revisiting this type of program at a later date.

300 ALTON ROAD PUBLIC-PRIVATE MARINA REDEVELOPMENT PROJECT INCLUDING NEW RESIDENTIAL TOWER

## **Executive Summary:**

These proposed ordinances/resolutions use the "vacation" of Alton Road to restore the FAR to the building site. The use of "vacations" by the Miami Beach Commission has grown from vacating small alleyways to more recently include major thoroughfares even though the City Charter requires that increases in FAR be approved by voters. While the City Attorney has provided an opinion that "vacations" are legal, they appear to violate the spirit of the charter amendment on FAR increases.

#### Why It Matters:

- City Charter requires that increases in FAR be approved by voters.
- The use of "vacations" by the MB Commission has grown from vacating small alleyways to more recently include major thoroughfares.
- MBU is not taking a position on the merits of this project or the deal negotiated, but cannot support the proposed ordinance changes unless the FAR increase goes before the voters.

#### **Executive Summary:**

This proposed ordinance amendment would allow rooftop movie screens with accessory bars along Alton Road which could become a noise and light disturbance to residents.

## Why It Matters:

- Residents will be disturbed by the noise from rooftop accessory bars and the light from movie screens.
- The burden will be placed on residents to file noise complaints, which has not been an effective deterrent in the past.
- Residents have expressed concerns about this proposed use that have not been adequately considered by the administration.

This resolution seeks to increase the buildable square footage currently permitted by allowing the exemption of structures such as stairwells, elevators and electrical rooms to be excluded in the FAR calculations.

### Why It Matters:

- FAR calculations determine the allowable size of a structure.
- Excluding structures such as stairwells, elevators and electrical rooms from the FAR
  calculations without specific limits on the size of the area for each proposed
  exception creates an open-ended framework for new construction.

# AMENDMENTS TO LAND DEVELOPMENT REGULATIONS FOR WOLFSONIAN ARTS DISTRICT TO EXPAND FAR FROM 1.5 TO 3.25

## **Executive Summary:**

While Miami Beach United is an enthusiastic supporter of the Wolfonian expansion proposal, this ordinance seeks to increase the allowable FAR from 1.5 to 3.25 and if passed, could have significant implications for the look, feel, and character of our City. MBU urges the Wolfsonian to revisit the plans as had been discussed previously in order to design to a maximum allowable FAR of 3.0, which is already permitted within the City codes.

## Why It Matters:

- Maximum allowable FAR is 3.0
- Allowing the increase to 3.25 sets a precedent that could change the feel and character of our City dramatically.

Miami Beach United **OPPOSES** this resolution <u>only on the basis that the FAR should not</u> exceed the allowable 3.0.
