MIAMI BEACH UNITED LETTER TO COMMISSION

Miami Beach United **STRONGLY** urges the Commission and Manager to defer all issues substantively affecting North Beach development and quality of life (including but not limited to issues pertaining to the creation of a Community Redevelopment Agency, the Tatum Waterway, the Byron Carlyle, etc.) until such time when residents, Commissioners and city staff have a better sense of their new normal as dictated by COVID-19 and its effects on the economy and the future budgets of the City of Miami Beach. Only then can we focus on significant issues potentially affecting quality of life in our City. In addition, all such matters brought to the Commission in the future should be considered 'Resident's Right to Know' items.

MIAMI BEACH UNITED RESOLUTION R9-D MAKING ALL CITY-RELATED AUDITS PUBLICLY AVAILABLE THROUGH MIAMIBEACHFL.GOV SITE

Agenda Item R9-D

Executive summary:

Miami Beach city-related audits are available to the public via a public records request, though filling these requests can be time consuming for city staff. To save the city clerk's office time and expense and to promote transparency these records should be readily available on-line. In previous years the city website contained a web-page that included city-related audits. This page no longer exists. Miami Beach United, therefore, is in **STRONG SUPPORT** of making the following information easily accessible again on the city website via a unified page including (but not necessarily limited to) the following:

- Public Audits of City Departments
- · Public Audits of City Vendors
- Related City management responses

Why It Matters

To facilitate access to city-related audits

- To save the city clerk's office time and expense
- To promote transparency of these records and make them readily available on-line
- To grant residents access to this information via a unified page
