**DESIGN REVIEW BOARD ADVISORY PROCESS** 

R5A

#### **Executive Summary:**

This resolution requires Design Review Board advisory input of City neighborhood projects for above ground exterior aesthetics. This includes but is not limited to: pump stations, generators, pedestrian bridges, and landscaping of of street-ends and major road projects.

#### Why It Matters:

- It will lay out a plan and shorten the amount of time to complete projects.
- · Solves the problem of costly project do-overs.
- Requires that residents be notified.
- Adds transparency by reporting the plan in the public record.
- Allows for resident input and participation in projects that directly impact their quality of life and property values.

Safeguards that are already enacted, including being able to reach business operations 24-hours a day, are not working well enough to curtail the reckless driving behavior permeating the Ocean Drive corridor and spreading to other areas.

- Rental companies must be held accountable for unchecked behaviors on the part of their customers that not only risk everyone's physical safety but also jeopardize drivers.

#### FAENA DISTRICT OVERLAY

#### R5T

#### **Executive Summary:**

This resolution seeks to secure a height increases for the Faena District Overlay, which is a historic district. There is already an existing approval for a 200 foot tower plus a 3 foot waiver and the new tower, which is proposed at 250 feet, would dwarf the historic Versailles.

#### Why It Matters:

- Tall modern buildings can overshadow their contributing historical structures.
- · Height increases in historic districts must be considered very carefully.
- Another increase in height would put undue pressure on the Historic Preservation Board in their attempts to ensure compatibility with nearby buildings.
- Developers who purchase historic gems must be held accountable to their preservation regardless of any other incentives, whether real or perceived.

#### Why It Matters:

- The current disregard for traffic and City laws by bad operators must be resolved before more electric modes of transport are introduced.
- It is always a good idea to consider new technology, especially if it's bio-friendly, but safety concerns for residents, tourists and motorists must be a top priority.

#### R9N

This resolution supports eliminating the requirement that all new stormwater pump stations be served by a dedicated back-up electrical generator and instead consider using the two or more independent electrical feeds provided by FPL.

#### Why It Matters:

- Permanent generators can create significant eyesores.
- Permanent generator installations can be very costly, draining funds from the limited sources available to expand the number of pumps.
- The need for permanent generators should be evaluated on a case-by-case basis.
