REFERRAL TO THE LAND USE AND SUSTAINABILITY COMMITTEE TO DISCUSS

AMENDMENTS TO LAND USE DEVELOPMENT REGULATIONS

C4A

Executive Summary:

A referral for review of Land Use Development Regulation (LDR) amendments by the Historic Preservation Board (HPB) in order to regulate the height, massing and scale of specific projects within the City's local historic districts.

Why It Matters:

- It is important that the Historic Preservation review any change in the LDRs that impact height, massing or scale within the City's local historic districts before LDRs are considered by the Planning Board.
- Many LDR amendments are often put forth to move a specific project without adequate representation of the actual project proposed.
- Allows the Historic Preservation Board to make informed recommendations on amendments.

Executive Summary:

This resolution seeks to require that credit/debit cards be accepted as a method of payment for towing services in Miami Beach. Currently, the tow permittees accept cashonly, which is antiquated, inconvenient and lacks transparency. The world is moving towards a cashless society and so should Miami Beach.

Why It Matters:

- Cashless payments lower crime rate by preventing money laundering, creating a digital trail, and is an easier method for international visitors.
- Credit card requirement is codified in most of South Florida, including the City of Miami.

Executive Summary:

Following the results of the recent election in which residents voted in favor of this FAR exemption, we urge the Commission to implement the will of the voters in a manner which ensures that the new exclusions from the calculation of FAR are not abused, and to utilize the staff estimates to establish maximum square footage that can be excluded from FAR calculations for each purpose.

Why It Matters:

- Left unchecked these FAR exemptions could be abused by developers to build more dense structures.
- The Commission should codify the recommended changes to limit open-ended increases.
